The City of Peterborough is the only township, which has duplicate plans within the township. Townships marked with an \* have had lands annexed to the City of Peterborough. The plans that are now in the City of Peterborough have been filed with the City of Peterborough plans and given an alpha suffix. (i.e. Ashburnham = A, Douro = G, Otonabee = S, Smith = T and North Monaghan = Q) The following page lists these plans and suffixes.

## Duplicate Plans within the City of Peterborough

Registered Plans begin at number “1” in all of the municipalities in the County of Peterborough. The use of the original plan number and the name of the original municipality will be sufficient to identify the plan, except as follows:

Registered Plans which originated in the City of Peterborough will be designated by the plan number, with no suffix, and City of Peterborough as the municipality. Registered Plans which originated in a part of a municipality which was subsequently annexed to the City of Peterborough will be designated by the original plan number with the appropriate original municipality suffix code, and City of Peterborough as the municipality.

The following Registered Plans will require suffixes and will be shown as indicated below:
